Video Services

Most schools have a Polycom HDX 7000 system. Good deals are being offered by The Videoconference Store on used HDX 8000 and 9000 systems. LACA can also sell Blackboard, an alternative to Moodle, for a cost of \$2600 per year (including instructor training) through a hosting agreement with SCOCA, another ITC in south-central Ohio. A listing of next year's video distance learning classes offered through LACA and the ECOESC was distributed to the group. All AP classes offered through video distance-learning can be paid for with the iLearn grant, with the exception of the course materials. Ohio K-12 Network Updates

It does not appear that subsidies will be cut next year, and will remain at \$1800 per building. This is not official yet, but there is no indication that it will be cut. The K-12 Network Committee is reviewing a proposal to take all primary (HS) links to districts to 1GB and secondary links (Elementary schools) to 100mb. This is being driven by the electronic assessments that are to be

done in 2014. ODE distributed a list of locations where informational seminars will be held about the new student assessments starting in 2014. LACA passed this on to everyone.

WAN Updates

LACA Core Network Upgrade – March 15 at 10:00-11:00pm LACA's core 6500 switch will need rebooted so it will boot onto updated software and recognize the new 10GB module that was installed. March 29 starting at 5:00pm until 10:00pm, will be replacing our main internet firewall with a 10gig capable model. This will take down access to the Internet. After this is complete, we will be moving individual districts into a newer module in the 6500, but this will be scheduled with each district.

Technical Services Update

E-Mail – Nearly everyone is moved with the exception of one district and two non-pubs. Chad Carson asked if there were any outstanding issues or items we need to address, and none were brought up.

VoIP Partner – LACA is now working with MCPC for future VoIP installations and implementations. Robert Rittenhouse will be providing day-to-day support, allowing LACA to significantly reduce costs for the VoIP project.

Unfinished Business

Managed Wi-Fi Service – Working with Powernet Global, LACA is currently evaluating gear from Ruckus Wireless. This is a service we can bid on and begin offering July 1. LACA will own the gear (access points and on-site controller) and lease it on a monthly per/AP cost. If you are interested in this service, please contact Chad Carson at LACA.

New Business

BYOD - Chad Carson distributed some sample BYOD/BYOT policies for review by everyone. LACA can create a template as a starting point for the group if that would be helpful. It was agreed that would be useful. Some topics to include in the template would be policy on teachers/students losing/damaging equipment, who pays if they do, etc.

Safari Montage – LACA has brought up the option of trying to get a group rate on Safari Montage, however our timing was usually right after renewals of other systems was complete. We are bringing this up again so there is plenty of lead time to review this product and make a decision before the new school year starts. Many districts indicated that the technology coordinator is not necessarily the person that decides to buy this; it is more the curriculum director. Speak to your curriculum directors and if they want are interested or want to see a demo, please let LACA know.

Study Island - The group was asked if there was interest in seeing a Study Island demo. There was not sufficient interest from the group.

Support for HP/Juniper switches – LACA has historically always assisted with the first Cisco switch attached to our demark (LACA's 3560 switch or router). We will now officially support HP and Juniper switches as well as Cisco.

Topic-Based Meetings – Apple will present on iPad Management in schools on April 4, 2012. Jamison Ables from Newark will also demo Casper software in use a Newark City Schools.
